

Summary Report – AGM and Directors Meeting

5th November 2014 at Catholic Club Liverpool NSW

Annual General Meeting

State Association Presidents (or nominees) attended the NACC AGM to deal with the agenda as previously distributed. Each state and the ACT were represented as follows:-

Qld - Bob McKernon (President of CCQ)

NSW - Des Hartree (Nominee of John Spencer, President of NSW State Assoc)

Vic - Peter Hillas (President of ACCVic)

ACT - Ray Swift (Nominee of Heather Ferme, President of Canberra Caravan Club)

SA - Reg Merritt (President of ACCSA)

WA - Derek Atkinson (Nominee of Ted Walker, President of WAACCI)

Apart from the usual procedural matters at any AGM, there was a special resolution adopted which reduced the number of Directors on the NACC Board from 13 down to 7. There is now one National Director who also holds the position of Company Secretary/Public Officer along with one Director for each state and the ACT.

The resolution also included the introduction of Alternate Directors who can attend NACC meetings but do not have voting rights or the right to move motions. In cases where the State Director is absent, then their Alternate Director will have full rights as a Director. Meeting minutes and other information will be provided to Directors as well as Alternate Directors to ensure continuity.

Funding attendance at meetings will now be the responsibility of NACC for Directors, but State Associations will be asked to fund Alternate Directors attending meetings.

Directors Meeting

Immediately following the AGM, a Director's meeting was held to deal with the agenda as previously distributed.

Reports were received from the 15th National Rally (Rockhampton Sept 2013); 16th National Rally (Canberra 2016) as well as 17th National Rally to be held in WA in 2019.

A report on the activities of MoTOURing Australia was tabled. This body is made up of representatives from CMCA, NACC and ATMC&CC and is focussed on matters affecting all RV travellers across Australia. The group meets twice a year and is very useful in presenting one voice on behalf of RVer's to governments at all levels.

The topic of varying length and weight limitations imposed by State Motoring Associations in their towing policies was raised but there is more information to be gathered before any submissions are made to try to have uniform arrangements across Australia.

The NACC registration process and benefits scheme came in for considerable discussion. As this topic is also linked to how NACC is funded, both items were included in a briefing paper which contained several recommendations for change. The changes, as adopted, were included in a separate document which was sent to all State Association secretaries and Directors/Alternate Directors on 11th November.

Obviously there is a good deal of further work to be done to refine the registration process but the necessary structures have now been agreed by all states on the funding arrangements and registration.

After several revisions and reviews during the months prior to the meeting, the proposed Purpose and Objectives of NACC were accepted. Hopefully these will serve as a guideline as to what the NACC will be doing to achieve its purpose which is to support caravanners across Australia.

At the conclusion of each Director's meeting, an Action Plan is created which sets out how the various tasks are to be completed, who is involved and importantly sets dates for delivery. Pleased to advise that the majority of the items listed after the 11th March 2014 meeting have now been achieved. A newly designed logo/letterhead was created and the NACC web site has been completely overhauled to make it as relevant as possible to those who visit seeking information.

One of the on-going challenges is communication. What is well understood is that we rely on State Association Secretaries to disseminate information to their affiliated club secretaries and for the club secretaries to then ensure their members get the information. Of course it is up to the NACC to make information on their activities available and extra effort will be directed towards achieving this in the future.

Thanks to all State Association representatives who made the effort to attend the meetings and for working together to ensure that club member's interests are being served.

Funding NACC Ltd and Registration Changes

At the NACC Directors meeting held on Wednesday 5th November, the issue of how to fund the operation of the NACC and the Registration process were discussed at length. It was agreed that the funding of NACC should be the responsibility of all affiliated club members and not primarily the limited number who choose to register in order to obtain benefits such as the RV Insurance Scheme.

Apart from funds received as a distribution from the profits of National Rallies, NACC has few other sources of income to meet its costs. Since the start of 2014, the NACC Board has commenced a regular meeting schedule of two meetings per year, one in March and one in November (in conjunction with the AGM).

The total cost to bring all the Directors (7) to attend an NACC Board meeting including overnight accommodation is approximately \$2,000. The figures in recommendation 2 (below) would provide approximately \$4,500 and cover the costs for the two meetings per year.

The recommendations adopted at the meeting include:-

- That each State Association (6) continue to pay a fixed fee of \$300 pa (as currently charged) (these funds cover the general running costs of NACC)
- That each affiliated club pay an additional fee of \$1 per van to their State Association and this be forwarded on to the NACC - (these funds cover the cost for two Board meetings per year)
- 3. That the new fees commence on 1st July 2015
- 4. That the current registration fee of \$5 be abolished from 1st January 2015. The existing registration process to continue until 1st July 2015
- That a new registration process be developed and trialled with implementation to commence 1st July 2015. The registration process is to ensure only bona-fide affiliated club members can access the Benefits Scheme

The NACC Board has resolved to provide better feedback to all affiliated club members on what has been done to further the interests of caravanners. This will be by way of more regular newsletters to the State Associations who in turn will disseminate that information to all affiliated clubs. The new NACC web site at www.nacc.asn.au is just one step in the process of providing up-to-date information for club members and the general public.
